COMPETITION RULES AND REQUIREMENTS

To be eligible, students must:

- Be in the 10th, 11th or 12th grade.
- Reside in the home of a parent or legal guardian who is a current Bluebonnet member with an active account and whose primary residence is within the outer boundaries of Bluebonnet's service area (including city limits that are within those outer boundaries); attached affidavit must be completed and signed before a notary public by parent or legal guardian.
- Participate in the tour to Washington, D.C., the Texas State Capitol and the Bullock Texas State History Museum June 12-21, 2019.
- Submit a completed application form and one original letter of recommendation to Bluebonnet Electric Cooperative at a Member Service Center in Bastrop, Brenham, Giddings, Lockhart or Manor or postmarked by **5 p.m. Jan. 18, 2019**.
- Attend an oral presentation and personal interview Monday, Feb. 11, 2019, at 6 p.m. at Bluebonnet's Headquarters, 155 Electric Ave., Bastrop.

APPLICATION PROCEDURES

Applications will be considered when all of the following information has been received by Bluebonnet Electric Cooperative, either in person or postmarked by 5 p.m. Friday, Jan. 18, 2019. No handwritten entries will be accepted. Entry must include:

1. A typed, completed and signed 2019 Bluebonnet Government-in-Action Youth Tour application.
2. One original letter of recommendation (i.e., from a teacher, civic leader, clergy member or employer). *No form letters, please.*
3. A copy of current high school transcript.
4. A list of awards and school activities (high school only).
5. Photograph release form, signed.
6. Affidavit of Parent, Legal Guardian, or Primary Managing Conservator, signed & notarized.




